As CNN reports, California has the most Tesla owners in America, and that Democrats by a 2:1 margin own more Teslas than Republicans. Hence, it is safe to say the green revolution is eating its own.

The quote about those who would rather rule over ashes also describes many of the protesters who are complaining that the DOGE effort is resulting in too many firings and layoffs. Albeit many of the people who are no longer working for the federal government took an early buyout or were new employees still on probation. Thus far, however, the Trump administration hasn't come close to the 400,000 federal workers fired by President Clinton in the early 1990s.

Lost on these people is how perilously close America is to bankruptcy. That is, Trump's simultaneous attempts to reduce our foreign trade deficit, revitalize



American manufacturing and industry, unleash our energy sector, reduce fraud and frivolous spending, and reduce the size of the federal bureaucracy couldn't come a moment too soon.

In the Annual Financial Report of the United States Government signed by **Janet Yellen** in January, 2025 for the fiscal year 2024, she outlines the fact that comparing total government assets of \$5.7 trillion (including \$1.8 trillion of loans receivable, net and \$1.3 trillion of Property, Plant, and Equipment (PP&E)) to total liabilities of \$45.5 trillion (including \$28.3 trillion in federal debt and interest payable, and \$15.0 trillion of federal employee and veteran benefits payable) yields a negative net position of \$39.9 trillion.

Furthermore, the report indicates that the debt-to-GDP ratio was approximately 98 percent at the end of FY 2024. Under current policy and based on this report's assumptions, it is projected to reach 535 percent by 2099. The projected continuous rise of the debt-to-GDP ratio indicates that current policy is "unsustainable."

Hence, the United States government brings in some \$5 trillion per year in tax revenue and spends nearly \$8 trillion for a deficit-spending budget of negative \$3 trillion. We owe some \$45 trillion, so at the current deficit spending annually of negative \$3 trillion, our government debt would grow to over \$50 trillion in just two years... and that doesn't include the trillions owed for Social Security and Medicare commitments. And yet, people are protesting Trump's effort to eliminate waste, fraud, and abuse?

California Governor Gavin Newsom is showing the breadth of his economic illiteracy – or just plain old political deceit.

Last week, Gov. Newsom and State Attorney General Rob Bonta sued President Donald Trump over his tariff's – the first state in the country to do so.

"According to the suit, which was filed in the U.S. District Court for the Northern District of California, they argue that the tariffs are illegal because, under the U.S. Constitution, only Congress has the power to put tariffs into place."

Then Gavin Newsom whined that his own 4 kids have lots of cheep toys from China under the Christmas Tree, so the U.S. needs to keep the cheap crap from China rolling in: "I've got four kids, 80% of their toys under the Christmas tree come from China. I've got family members that live paycheck to paycheck, many family members."

**C**ounty supervisors have a very bad habit of looking through the wrong end of a telescope. Or, as Groucho Marx would have put it, "Politics is the art of looking for trouble, finding it everywhere, diagnosing it incorrectly, and applying the wrong remedies." In no situation has this been truer than in government's approach to so-called "affordable housing."

The tag team of the City of Santa Barbara, County Supervisors, and our State Legislature are in the process of destroying the once sacred ambience of Santa Barbara. The one thing I have heard constantly since I was a kid growing up in this region is that the last thing Santa Barbara wanted to become is another Orange County or San Fernando Valley. That is, they didn't want tall buildings, urban sprawl, high density or beach-side development, or the elimination of open spaces. Now they are getting all those things and more because of state mandates demanding that each community build its "fair share" of housing along with the quest for affordable work-force housing.

The sinister aspect of this no-growth mentality, which also applies to the Santa Ynez Valley, is evident in a quote I heard some 35 years ago which explains our local land-use policies heretofore: "The cost of preserving the high quality of life in Santa Barbara County includes limiting opportunities for others. It limits economic mobility, but that is a legitimate choice!" That statement embodied the marching orders for Santa Barbara County's Planning and Development Department as confessed by a former department director.

So, what is it? Preserve Santa Barbara or change it forever by high density and high-rise developments that create traffic nightmares, water shortages, and other problems associated with shoe-horning tens of thousands of units (the former Macy's and Sear's stores anybody?) that will overburden the resources to serve the same?

I, for one, don't believe you can make living in Santa Barbara or the valley affordable without some urban sprawl because too many people who don't need a job (the independently wealthy and the homeless!) want to live here and they are competing with the people who can't afford to live here, because their job pays too little compared to the cost of housing.

This brings us to a hearing which would have served to humiliate our county supervisors (past and present) and their staff had they not forgotten how to blush many years ago. Supervisor **Laura Capps** thinks she can make some housing affordable by taking county land and developing it, thereby eliminating the land cost associated with development. In other words, she wants to sacrifice county resources to put a band-aid on our hemorrhaging wound having to do with housing affordability.

What was lost on everybody at the hearing on this subject were some very disturbing details having to do with poverty rates in our county. That is, the main reason housing isn't affordable is not so much because of the price of housing (outside of Santa Barbara and the SY Valley), as much as it is that the city, county, and state have completely annihilated all the bestpaying jobs we once enjoyed. Simply put, the report indicated that a whopping 70% of the workers in this county are either poor or very poor. Moreover, the situation is getting worse; in the past five years, 40% of the workforce has become poorer than they were five years ago. Yet, nobody on the staff or the board mentioned this part of the report.

Here is Finding #1 from Harris and Associates who produced the report indicating that Santa Barbara County experienced a whopping 1% job growth in the last five years along with the following poverty indicators: The full report here.

Hence, the real problem is that government at every

# Trump's Electric Vehicle Rollback Helps Consumers, Won't Hurt Climate

# **P**olicymakers need to let the market work.

**B**efore we let Democratic legislators get on their high horses about the Trump administration's obliteration of California's climate goals via its elimination of the federal electric vehicle mandate, let's look at one statistic that should put matters in perspective.

Between 2003 and 2019, California reduced its greenhouse gas emissions by 13 percent thanks to billions of dollars in spending and myriad mandates designed to shift energy use to electric generation. Yet 2020's wildfires "caused twice the amount of greenhouse gas emissions" that were saved over those sixteen years, according to a University of Chicago report. Fires are obliterating any savings from our state's high-profile move away from fossil fuels.

If man-made climate change is for real, then it's imperative that we adopt the right policies rather than spend all our time fighting about the wrong ones. And it's about time that we start questioning the value of ongoing federal electric vehicle credits, which are designed to prop up sales of vehicles that most Americans don't want to buy, at least not yet.

As usual, Trump often explains matters in the most divisive manner possible. He once said electric vehicle policies are a "transition to hell." But Trump also said "that electric vehicles were suitable for a 'small slice' of the population and that 'you want every type of car imaginable' to be available," as reported by the *Guardian* in August. That's the critical point.

Since the election, Trump signed an executive order, "Unleashing American Energy," which set forth the following goal:

> To eliminate the 'electric vehicle (EV) mandate' and promote true consumer choice ... by removing regulatory barriers to motor vehicle access; by ensuring a level regulatory playing field for consumer choice in vehicles; by terminating, where appropriate, state emissions waivers that function to limit sales of gasolinepowered automobiles; and by considering the elimination of unfair subsidies and other illconceived government-imposed market distortions that favor EVs over other technologies and effectively mandate their purchase by individuals, private businesses, and government entities alike by rendering other types of

vehicles unaffordable.

As the Associated Press reported, electric vehicle sales nationwide account for only 8 percent of new vehicle sales — and automakers "have pulled back ambitious plans to go electric" following declining sales and falling prices. The Trump policy has particular impact in California, as the administration "seeks to terminate a federal exemption that allows California to phase out the sale of gas-powered cars by 2035." Electric vehicle sales in California are much higher than the national average, at 25 percent of vehicle purchases. But even those sales have stalled and fall well short of the state's goals.

California's goals are of national importance given that, as the *San Diego Union-Tribune* summarized, "[D]ue to the sheer size of California's automotive market, carmakers end up complying with the Golden State's stricter standards, thus resulting in a de facto policy for the entire country." I'm a big fan of federalism, even when our state typically pursues the wrong course, but this does seem like a legitimate national issue — especially given that it's dependent on a federal waiver.

## What Exactly Have NIH Grants Got Us?

The US is by far the world's leading funder of biomedical research. But the Trump administration reportedly plans to ask Congress to cut the budget of the National Institutes of Health from \$47 billion to \$27 billion as part of its effort to rein in out-ofcontrol federal spending.

Not unexpectedly, grant recipients and their support communities are up in arms. They claim that the proposed cuts would deprive researchers of the funding they need to find cures. They say the US will lose its global dominance in the field, along with enormous profits.

But the critical questions are: "What does NIH-funded research actually accomplish?" and "Are the accomplishments worth the money?" The answers, at least according to NIH itself, seem to be shockingly little for the vast sums spent.

On its website, NIH divides its accomplishments for 2024 under three headings: (1) "Human Health Advances"; (2) "Promising Medical Findings" and (3) "Basic Research Insights." Under each heading are five NIH-touted accomplishments.

The first item listed under "Human Health Advances," a category that represents the latest and greatest from NIH research, is "Accurate blood test for Alzheimer's disease." After listening to a leftist talking head attack President Trump and Elon Musk for "setting back Alzheimer's research 20 years" with funding cuts, I looked into the Alzheimer's advance that NIH had touted at the top of its list of accomplishments.

The advance referred to a July 2024 study published in the *Journal of the American Medical Association* reporting on a new blood test that had, with 90 percent accuracy, correctly diagnosed Alzheimer's among 1,213 Swedish Alzheimer's patients.

While that may sound impressive, the study authors qualified their results with two key caveats: (1) More testing was needed in other cohorts of patients to confirm their results; and (2) "Future studies should evaluate how the use of blood tests for these biomarkers influences clinical care." Far from being a "Human Health Advance", the researchers admitted that they still needed confirmation of their results and that they're not sure the blood test will have any usefulness even if the results are confirmed.

As to NIH taking credit for the "advance," such as it is, NIH was just one of 20 different funders of the research. It awarded a total of \$993,478 to two Swedish researchers. The other 14 Swedish researchers on the study were apparently funded by the other 19 or so Swedish funders.

The study is really only noteworthy because NIH anointed it as the top "advance" for 2024. But what does that say about the other \$36.8 billion NIH spent on 60,000 other grants? A not-ready-for-prime-time Alzheimer's blood test is its pride and joy among all that funding?

A recent *Washington Post* op-ed entitled "Science needs more shrimp on treadmills" opined that "the National Institutes of Health isn't funding too much silly science. It's not funding enough." The author tried to credit NIH with the development of weight loss drugs like Ozempic. In 1984, an itinerant NIH researcher published a study on Gila monster venom. After four decades of research elsewhere, others used the finding to develop the now blockbuster GLP-1 drugs. In some ways, that's an amazing story. On the other hand, it's not evidence that NIH's huge spending is producing results for taxpayers.

## Why DC Remains One Of The Nation's Most Dangerous Cities

Once in a blue moon, you run across a statistic or record that is mind-boggling. Some are amazing, like Alex Ovechkin's 895 goals or Serena Williams' 23 Grand Slam singles titles. But others are disturbing, like the fact that in Washington, D.C., between 2018 and 2022, only 1.7% of people arrested for carrying a pistol without a license were sentenced to prison.

This dismal record comes from the District of Columbia Sentencing Commission, which analyzed arrest and sentencing trends in the District's Superior Court for carrying a pistol without a license.

Before unpacking how and why only 97 of the 5,558 adult arrests that contained at least one charge for carrying a firearm without a license ended up in prison, let's step back and look at the bigger picture in the nation's capital—the astronomical homicide rate—and connect the dots between that rate and guns.

According to the D.C. Metropolitan Police Department, firearms are used in approximately 77% of all homicides in Washington, D.C. Knives come in a distant second place at 14%.

National Institute for Criminal Justice Reform figures show that 95.8% of homicide suspects in the District are male, and 96.8% of those are black. Over 70% of suspects are between 18 and 34 years old. To look at the victim numbers, 89% are male, of whom 94.1% are black. Over 62% of homicide victims are between 18 and 34 years old.

More than half of homicides in D.C. are the result of personal disputes, group-related conflicts, instant disputes, or drug-related disputes, according to the institute.

In her letter to the Trump "D.C. Safe and Beautiful Task Force," Mayor Muriel Bowser touts a 35% drop in violent crime in 2024 compared to 2023, including a 32% drop in homicides. She acknowledges that "the District still has work to do" in "making DC the safest city in the country." Talk about an understatement!

She must believe that President Donald Trump, Attorney General Pam Bondi, and others are oblivious to how much higher crime rates are in D.C. compared to other cities, and how broken the system is from the inside out. Perhaps she doesn't realize just how bad it is here in D.C.

In 2023, D.C. had a homicide rate of 40.9 homicides per 100,000 residents and ranked fourth-worst in the nation behind only New Orleans (53.8), St. Louis (53.7), and Detroit (40.9). The homicide rates in the District per 100,000 residents in years past were 30 in 2022, 34 in 2021, and 29 in 2020. It was 25 or less in all the previous eight years and was as low as 14 as recently as 2012.

The homicide rate in 2024 was 27.3, according to the Center for Public Safety Initiatives at Rochester Institute of Technology. While a big drop from the 2023 spike, it still ranked fourth-worst in the country. If D.C. were a state, it would have the highest homicide rate of any state in the United States, and would be retaining that dubious title year after year.

With that background in mind, let's unpack the commission's gun arrest and sentencing data from 2018 to 2022.

Of the 5,558 total arrests for carrying a pistol without a license, the U.S. Attorney's Office for the District of Columbia—essentially the local DA—refused to file a charge in 1,933 (34.2%) of those cases.

## Judges Usurping Presidential Authority Should Face Impeachment

In a recent blatantly illegal ruling, an Obamaappointed federal judge interfered with the legitimate powers of the president.

In his ruling, District Court Judge James Boasberg ordered the Trump administration *not* to deport a group of Venezuelan nationals who pose a danger to our country.

In an apparent attempt to thwart President Donald Trump's agenda, the American Civil Liberties Union (ACLU) and other plaintiffs filed a lawsuit seeking judicial intervention in halting the removal of terrorist gang members from the United States.

Within a few hours of the filing, Judge Boasberg issued a ruling complying with the left's request. He granted a motion for injunction which sought to prevent the administration's implementation of the president's proclamation for a 14-day time period.

In a further overreach, the judge ordered an aircraft that was *en route* to deport the illegal immigrants to return back to the U.S.

"Any plane containing these folks that is going to take off or is in the air needs to be returned to the United States however that is accomplished," Judge Boasberg wrote.

U.S. Atty. Gen. Pam Bondi declared that the judge's order "disregards well-established authority regarding President Trump's power, and it puts the public and law enforcement at risk."

In an emergency filing, the Trump administration appealed the order with the D.C. Circuit Court of Appeals so that Judge Boasberg's order would be placed on hold.

The appeal noted that if the order were allowed to stand "district courts would have license to enjoin virtually any urgent national-security action just up-



on receipt of a complaint."

Interestingly, the president hadn't yet signed a proclamation on the matter at the time the lawsuit was filed by the ACLU and other left-wing groups.

The Trump administration was correct to point out the fact that halting a presidential act *before* it has been announced would neutralize the executive branch.

The Venezuelan nationals in question happen to be members of *Tren de Aragua* (TdA), an international gang that has officially been declared by the Trump administration to be a terrorist organization.

The gang became part of a national news story following last year's armed takeover by TdA of apartment complexes in Aurora, Colorado.

It continues to victimize numerous other cities across the country.

TdA is linked to a narco-terrorism enterprise based in Venezuela and sponsored by the Nicolás Maduro regime.

Members continually exhibit unspeakably brutal behavior and are additionally involved in the facilitation

of human trafficking, drug peddling, kidnapping, extortion, and other heinous activities.

To protect the public from the Venezuelan gang, President Trump did what other presidents before him have done: he invoked the Alien Enemies Act of 1798.

Within his capacity as the nation's chief executive, Trump possesses the explicit power, designated in Article II of the Constitution, to identify threats to the country and act accordingly to protect the American people.

In the proclamation, President Trump asserted that the regime of Venezuelan President Maduro "is a hybrid criminal state that is perpetrating an invasion of and predatory incursion into the United States, and which poses a substantial danger to the United States."

Judge Boasberg has ordered members of the TdA gang to be brought back into our country.

Of great significance, this is the same judge who was in charge of the FISA Court, when that court was used to illegally spy on President Trump.

Judge Boasberg's March 15 order was issued after Venezuelan gang members were already in transport via plane to the country of El Salvador.

"Today, the first 238 members of the Venezuelan criminal organization, Tren de Aragua, arrived in our country," El Salvador President Nayib Bukele posted on X.

He added, "They were immediately transferred

to CECOT, the Terrorism Confinement Center, for a period of one year (renewable)."

In response to Judge Boasberg's order, President Bukele posted the following, "Oopsie . . . Too late."

Congress is the branch that has within its power the ability to impeach federal judges who abuse their authority. It has done so in the past.

To this end, Rep. Brandon Gill, R-Texas, indicated in a post on X that he will be filing the necessary paperwork to impeach Judge Boasberg.

Elon Musk reposted the tweet and wrote that the impeachment is "necessary."

In this writer's legal opinion, if ever there were a case in which a judge was deserving of impeachment, this is it.

Unfortunately, activist judges have increasingly been intruding upon executive authority.

Judge Boasberg's ruling is one of the most egregious examples of the violation of the fundamental constitutional principle of separation of powers --that crucial system of checks and balances between the three branches of the federal government.

Why the massive drop-off from arrest to charging? Are cops making bad arrests? If so, why? Did they violate the suspect's Fourth Amendment rights? Are the prosecutors not able to prove a case beyond a reasonable doubt?

You would think that a 34% drop-off between arrest and charging would deeply concern the prosecutor's office. Most big city prosecutors' offices work closely with police departments and engage in weekly or monthly trainings. But not the D.C. U.S. Attorney's Office. Why not?

It's not like these are hard cases to prove. The elements are straightforward: You can't carry, either openly or concealed, any deadly or dangerous weapon or a pistol that is not licensed by the District. Firsttime offenders can be sentenced up to five years in prison. Recidivists face up to 10 years' imprisonment.

Worse, another 1,213 (32.7%) of the original 5,558 arrests were closed without a conviction. Poof. Just gone. Why?

One clue may be the fact that the D.C. U.S. Attorney's Office is woefully understaffed when it comes to inhouse investigators. District attorney's offices typically employ investigators who are assigned to line prosecutors and continue investigating cases to develop additional evidence once the police make an arrest and charges are filed against an individual.

The San Diego DA's office, for example, has 330 prosecutors and 120 investigators, or one for every 2.3 prosecutors. The Riverside County DA's office has 126 investigators, or one for every 1.6 prosecutors. The Los Angeles County DA's office has 900 prosecutors and 300 investigators, but it is authorized to have up to 400.

In contrast, D.C. has 330 prosecutors and only three investigators. That's right, three! This helps explain why cases fall apart in the District even after charges are filed.

As if that's not frustrating enough, only 2,218 cases (39.9%) of the 5,558 arrests resulted in a conviction for any criminal offense, although 279 cases (7.5%) are still pending. Of those 2,218 convictions, 654 (29.5%) were for misdemeanors and 1,564 (70.5%) for felonies. Out of the 1,564 felony convictions, 85

defendants have yet to be sentenced. Out of the 1,479 cases in which a sentence has been imposed, only 819 contained a conviction for carrying a pistol without a license (CPWL) or its equivalent—although, in fairness, some of the defendants in the remaining 660 cases were convicted of more severe offenses.

Of those 819 CPWL felony convictions, 57.7% got sentenced to probation and 30.5% got a "split sentence," meaning they got sentenced within the local sentencing guidelines that included a jail sentence of six months or less.

In sum, then, out of the original 5,558 individuals arrested for CPWL over a five-year period, only 97 (1.7%) were given a prison sentence for carrying a pistol without a license. Even if one assumes (although I don't know why one would) that the 279 pending cases and 85 cases in which a sentence has not been imposed will all result in a conviction and prison sentence for a CPWL offense, the percentage would still be pitifully low.

These mind-boggling and shameful statistics expose a sclerotic criminal justice system that doesn't take gun crimes seriously. Unless and until that happens, D.C. will remain a long way off from being the safest city in the country.

President Nixon launched the "War on Cancer" in 1971, Every President since has tried to make his mark in that effort, but breakthroughs have limited. In 1986, all-star biostatistician John Bailar observed that cancer remained undefeated. In 2018, cancer researchers reported in the *British Medical Journal* that the expensive drugs recommended by US cancer treatment guidelines were based on "weak evidence." President Biden's "Cancer Moonshot" has produced essentially zero.

NIH mentioned no cancer progress under "Human Health Advances" or "Promising Medical Findings" for 2024. The sole mention of cancer comes in "Basic Research Insights" under "Mapping how cancers form and spread." Fifty-four years after the War on Cancer was launched, that is where we are.

None of this is to say that NIH shouldn't fund medical research. But if NIH continues spending taxpayer money, there must be some auditing of expenditures and reconciling of accomplishments. We are \$36 trillion in debt and cannot afford to spent never-ending billions of dollars on non-productive research in hopes that something will eventually turn up.

And no, there is no need to worry about foreign competition. We spend about 18 times more than the UK, our nearest competitor with respect to medical research. It may be that the rest of the world is freeriding on the backs of US taxpayers. It may also be that the rest of world has realized that there are more productive ways to spend their taxpayer dollars.

#### That's the fatal flaw in this electric vehicle revolution — it's led by policymakers and ideologues rather than consumers.

This order has set up a battle between California and the feds. California Governor Gavin Newsom in November vowed that the state will step up if the \$7,500 federal tax credit evaporates, which appears likely. But the real issue doesn't revolve around tax credits and mandates, but consumer demand. Electric vehicles certainly offer some advantages, although the cost savings aren't nearly as great as promised given the relatively high price of using public fast chargers.

"The Trump administration is not the biggest problem," Pacific Research Institute economist Wayne Winegarden told the *Union-Tribune*. "It's the price tag, the lack of [charging] infrastructure ... People still have fears taking them on long drives. They're still a niche product, more of a second car for wealthy people." Indeed, that's the fatal flaw in this electric vehicle revolution — it's led by policymakers and ideologues rather than consumers.

For instance, California banned the sale of new gaspowered lawn equipment beginning last year, which mainly caused people to nurse along aging gaspowered equipment. I recently was at a home improvement store and, yes, manufacturers have developed electric lawn tractors. From what I saw, they cost at least two times what similar gas-powered ones cost. As I explained on these pages previously, electric lawn mowers are great tools for small lots — but adoption should be driven by consumer needs, not policy dictates. often take longer trips. I'm spontaneous in my driving, so I don't like to plan ahead to keep the vehicle charged. A couple hundred miles of range won't work for me — but I'm open-minded enough to reconsider once those battery ranges hit the 500-mile mark. I'm not being unreasonable here; it's just that electric vehicles don't work for my needs. Why can't California policymakers at least consider that in their equation?

It's mainly a market problem that can only be papered over by subsidies and rebates. As the Competitive Enterprise Institute argued: "Our lawmakers would do well to heed this wake-up call. Rather than push Americans into vehicles they don't want and can't afford, they should focus on policies that allow greater consumer freedom and foster true innovation. The road to a prosperous future isn't paved with government mandates — it's built on the bedrock of options and innovation."

And consumers aren't stupid, nor unconcerned about climate issues. Note that the sales of gas-electric hybrids soared by 44 percent last year, given that they provide fabulous gas mileage, reduce greenhouse gases, and eliminate the charging and range-anxiety concerns endemic in all-electric vehicles. One can buy a high-quality non-subsidized hybrid in the \$30,000 range, which is another plus. Policymakers need to let the market work — and hybrids might simply be the market coming up with a transitional product.

In California, our lawmakers are committed to the idea of technology forcing — the use of unachievable regulations that force the industry into meeting the government-developed standards. As I noted previously for *The American Spectator*, this process creates unintended consequences and distorts economic

incentives, thus making the government rather than the consumer the king. Now, consumers seem to be rebelling against California's aggressive use of it, and Trump's approach promises to reset the calculation in a consumer-oriented direction.

All this effort to arm-twist consumers isn't getting anywhere. California's emissions account for less than 1 percent of global emissions, so even if we somehow eliminated all emissions, it wouldn't make a dent in what's spewing from Chinese and Indian factories. The state isn't doing a great job meeting its own goals. "California is poised to fail to meet its ambitious greenhouse gas reduction goals by the end of the decade unless it can triple its efforts to reduce carbon emissions statewide, according to a critical new report," per a *Los Angeles Times* article from last March.

Meanwhile, you might have noticed California had one of the worst wildfires in decades — made worse by the state's incompetent wildfire-battling strategies. Whatever the federal administration does on the electric vehicle front won't make any noticeable difference in the fight against climate change unless other California policies change. That's just reality.



one and that the gains offset any losses, the average American has experienced stagnating income and wide-spread job losses in manufacturing hours while the top earners have seen disproportionate income gains," ProsperousAmerica.org reports. "The top 10% benefit do not experience the job losses from import competition that the working class suffers from. And those at the top of the corporate ladders benefit from the lower wages needed to pay workers in developing countries compared to what they would have to pay Americans."

This imbalance has been devastating for U.S. industry. Since the North American trade agreement (NAFTA) was passed by the Clinton Administration in 1993, millions of manufacturing jobs have been lost, a huge trade deficit emerged and American manufacturing wages declined.

Gavin Newsom was silent on NAFTA – other than to burnish his globalist chops.

As President Trump lowers marginal tax rates, unleashes the many sources of abundant U.S. energy, and cuts regulations, the cost of everything will decrease, while his tariffs will increase costs on overseas manufacturing. rallies," over the last few years to assuage the woke community's collective guilt for the death of **George Floyd**, even though local taxpayers had nothing to do with the death of Mr. Floyd.

The second thing this wasteful spending reminded me of was a story taken from the book "The Life of Colonel David Crockett", written in 1884 by Edward S. Ellis. The story has to do with the time when Davy Crockett served as a member of Congress. As the story goes, Crockett had once voted in Congress to give a charitable donation of \$20,000 to a community that had been ravaged by fire. Upon return to his district, he was upbraided by a constituent, a farmer no less, who understood the limits of the Constitution better than does any member of Congress today.

The constituent, Mr. **Horatio Bunce**, had this to say, "... an understanding of the Constitution different from mine I cannot overlook, because the Constitution, to be worth anything, must be held sacred, and rigidly observed in all its provisions. It is not the amount that I complain of; it is the principle. In the first place, the government ought to have in the Treasury no more than enough for its legitimate purposes. The power of collecting and disbursing money at pleasure is the most dangerous power that can be entrusted to man, particularly under our system of collecting revenue by a tariff, which reaches every man in the country, no matter how poor he may be, and the poorer he is the more he pays in proportion to his means."

Mr. Bunce rightly warned, "You will very easily perceive what a wide door this would open for fraud, corruption, and favoritism, on the one hand, and for robbing the people on the other. Congress has no right to give charity. Individual members may give as much of their own money as they please, but they have no right to touch a dollar of the public money for that purpose. Congress only has the power to do certain things for which it is authorized to collect and pay moneys, and for nothing else. Everything beyond this is usurpation, and a violation of the Constitution."
